ANNOUNCEMENTS: Chairman Jackson announced that the Board would be going into Executive Session at the end of the Regular Session to discuss a Memorandum of Agreement for the dispatcher's union contract and would not be returning to Open Session. Selectmen Luther announced the Topsfield Police Relief Association in conjunction with the Topsfield Police Department is presenting "Ratatouille" on Friday, September 12 at 6PM on the Topsfield Common. Free popcorn and ice cream sundaes, along with motorcycle pictures, will be available. The event is sponsored by the Topsfield Fair, Chunky's Cinema Pub, the Station Sweet Shoppe and Richardson's Ice Cream. Rain date is September 13, 2008.

The Water Department's portion of the project is not state funded and therefore, the state requires the Town to submit signed documents acknowledging the Town's obligation to pay for that portion of the project. Selectman Luther made a motion that the Town enter into Agreement Number 56248, Non-Participating Agreement, with the Commonwealth of Massachusetts for the installation of water main and appurtences as part of the Ipswich Road Reconstruction Project to be administered by the Mass Highway Department, with the Chairman to sign, seconded by Selectman Morrison; so vote: 4-0.

New Business

My Classic Car Garage Inc: Selectman Luther made a motion to issue a Class II Used Car License to My Classic Car Garage, Inc. located at 16 Maple Street with 8 cars permitted to be displayed on the premises, seconded by Selectman Morrison; so voted: 4-0.

<u>Thomson Motors</u>: Selectman Morrison made a motion to issue a Class II Used Car License for Thomson Motors, located at 86 Central Street with 16 cars permitted to be display on the premises, seconded by Selectman Luther; so voted: 4-0.

<u>Rail Trail Appointments:</u> Selectman Luther made a motion to appoint Katherine Carlson and Roy Baessler to the Rail Trail Committee for a term to expire June 30, 2009, seconded by Selectman Morrison; so voted: 3-0-1, Chairman Jackson abstained as he was not in attendance the night the candidates were interviewed by the Board.

<u>Historical Commission Appointment</u>: Selectman Luther made a motion to appoint Mary Fletcher Ferrill as an Alternate to the Historical Commission for a term to expire June 30, 2009, seconded by Selectman Morrison; so voted: 3-0-1, Chairman Jackson abstained as he was not in attendance the night the candidate was interviewed by the Board.

<u>Masco Youth Hockey:</u> The Board of Directors of the MASCO Youth Hockey has solicited Topsfield to obtain permission to display the achievements of the 4th & 5th Grade hockey team that won the Massachusetts State Hockey Tournament in March of 2008. Chairman Jackson was hesitant to provide permission for the options that were suggested in a letter dated August 12, 2008 as it would set precedence. Selectman Gandt suggested that the winning game be shown on Cable TV and Selectman Luther suggested a certificate of accomplishments be provided to the Topsfield members of the Team and this be coordinated with the other towns for them to do the same.

<u>Auxiliary Police Officer:</u> Selectman Gandt made a motion to appoint David Castellarin as an Auxiliary Police officer for a term effective upon completion of departmental training and to expire June 30, 2009, seconded by Selectman Morrison; so voted: 4-0.

<u>United Nations Proclamation</u>: Selectman Gandt and Jackson have some changes that they would like to make to the proclamation.

<u>Daughters of the American Revolution Proclamation:</u> Selectman Morrison made a motion to proclaim the week of September 17th as Constitution Week as requested by the General Israel Putnam Chapter, Daughters of the American Revolution and with the Chairman to sign, seconded by Selectman Luther; so voted: 4-0.

<u>Sunday Public Entertainment Licenses</u>: Selectman Gandt made a motion to grant two Sunday Public Entertainment Licenses to Fiesta Shows, one for amusements rides and one for amusement games, at the Topsfield Fair on the Sundays of October 5th and 12th seconded by Selectman Luther; so voted: 4-0.

<u>Household Hazardous Waste Collection</u>: Selectman Gandt made a motion to approve the annual Household Hazardous Waste Collection agreement with Clean Harbors Environmental Services of Braintree, MA for an amount not to exceed \$5,000 for fiscal 2009 and for Chairman to sign, seconded by Selectman Morrison; so voted: 4-0. Selectman Luther announced that the League of Women Voters sponsors the hazardous waste day and is seeking volunteers to assist at MASCO on the day of the event, November 8 from 8:30AM – 1PM. Volunteers can contact Selectmen Luther to sign up.

<u>Flu Clinics for FY2009</u>: Selectman Morrison made a motion to approve the contract for services with Public Sector Partners, Inc. of Worcester, Ma to process Medicare reimbursement for the
